- 5. Stamped Address Envelope:** You can use this envelope to send us your completed contract booklet and bank statement header.

Please return no later than Friday May 15th 2026.

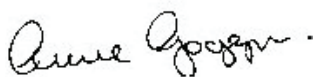
You have three options for return of required documents:

FREQUENTLY ASKED QUESTIONS

What are the terms and conditions?

The terms and conditions are included in this correspondence. It is a helpful document which may answer some of your questions.

I have questions. Who do I talk to?

Please contact your local catchment scientist. He/she will be happy to answer any of your questions and help you with programme entry. You'll find contact details on a flyer included in this pack.

I would like some help with completing my entry. Where can I go?

Come to your local clinic. You will be able to meet our catchment scientists in person. It will be a one-to-one meeting and all information will be treated as private and confidential.

If I sign the contract, what are the next steps?

- We will arrange a local training event for you to attend
- Your chosen advisor will complete a habitat assessment of your farm. This may entitle you to payments based on the nature quality of your farm.
- Your advisor will complete a runoff risk assessment of your farm with you and submit a plan for proposed supporting actions, which may be financed through the project. You will be paid €250 directly for your time.

Why do I need to work with an advisor approved by the project?

Waters of LIFE train the advisors working with the project on water quality, habitats and runoff risk assessment. The role of the advisor is to ease any burden on your working with the project. Advisors are paid directly by Waters of LIFE so there is no cost to the farmer.

What happens if I sign the contract, but then change my mind about getting involved?

You can exit the programme at any time with one month's notice.

What would be a minimum payment for the first year's involvement?

If you attend three training events and complete a runoff risk assessment in your first year, you can expect to receive €718. This amount could increase significantly based on the habitat scoring of your land and participation in general actions.

When will I be paid?

Payments for general actions and training are issued quarterly. Payments for habitat scores rely on information from DAFM, which comes late in the year. So these payments are made in the spring time of the following year.

What do I provide along with the EFT Form?

We need a copy of the top of your bank statement. It must contain:

- Your personal details including your name and address
- Your bank details including your account number, IBAN and sort code.

Please do not share any transaction history with us. You can cut off the bottom of the statement or fold it and photocopy it. You can also email us a cropped digital version to info@watersoflife.ie

Why do I need to provide a copy?

It avoids payment delays and mis-payments.

Why do I need to provide a tax registration number or PPSN?

If your farm is a commercial partnership or a corporate entity we'll need your tax registration number to process payment. Otherwise we will need your PPSN.
